OVERVIEW

The Subclass 858 visa is an elite, highly selective Permanent Residency visa designed to attract the world's most exceptional talents in **future-focused sectors** (e.g., FinTech, Agribusiness, Space, Health, Quantum Computing).

[This visa bypasses the traditional points system, focusing instead on verifiable, internationally recognized outstanding achievement and the potential to make a significant economic contribution to Australia.

Eligibility Criteria:

| Exceptional & Outstanding Achievement | Must be internationally recognised as prominent in your field with a record of sustained success, which is currently relevant. |
| Future Contribution | You must demonstrate that you would be an asset to Australia, especially economically, and be capable of easily finding work in your field. |
| Nomination | You must be nominated by a suitable Australian individual or organisation with a national reputation in your field. |
| Main Applicant Age | Generally, applicants must be under 55 years old at the time of application, unless they can demonstrate exceptional economic benefit to Australia. |
| Education | No specific formal qualification (degree, diploma) is required, as eligibility is based entirely on demonstrated talent and achievement, not academic background. |
| Spouse/Partner Age | The partner or spouse does not have an independent age limit for inclusion. |
| Children and Dependents | Dependent Children (usually under 18, or up to 23 if full-time students) can be included in the application. Parents and Siblings cannot be included in this specific visa application. |
| English Language | Must meet the level of Functional English (e.g., IELTS 4.5 average). |

Application Process

The Global Talent stream involves two main stages:

1. Expression of Interest (EOI):
 - Submit an EOI detailing your achievements.
2. Visa Application (Subclass 858):
 - File the official Permanent Residency visa application within the given timeframe, including all supporting documents and official fees

Processing Time

As a priority visa aimed at high-value individuals, the Subclass 858 often features a highly efficient processing time:

| Processing Stage | Typical Timeframe |

| Global Talent EOI | 1 weeks. |
| Visa process time | 4 to 6 months |

Documents Required:

- **Evidence of Achievement:** Awards, patents, high-level employment contracts, significant media coverage, evidence of high salary, and published academic papers.
- **Nomination Documentation:** Must have Nominator from the Australian (individual or organization) with a national reputation.
- **Identity & Character:** Passport, police clearances, and health examination results.
- **English Language:** Proof of Functional English proficiency.
- **Dependent Documents:** Marriage/de facto certificates and children's birth certificates.

Benefits:

- **Permanent Residency (PR):** Immediate, non-conditional PR for the entire family.
- **Unrestricted Life:** Freedom to live, work, and study anywhere in Australia.
- **Healthcare:** Full access to Australia's national public healthcare system, Medicare.
- **Social Security:** Eligibility to apply for certain social security benefits (subject to waiting periods).
- **Citizenship:** A direct pathway to Australian Citizenship after meeting the required residency criteria.
